Our beloved harvester had several mechanical issues that had to be rectified, as a result, several areas of the lake experienced a higher than normal amount of weed infestation. One harvester incident involved the breakdown of a specialized part that is no longer manufactured, or available to purchase. Upon hearing of our dilemma, Mark immediately instructed the people at his business to do whatever was needed to design and manufacture the replacement part. Within just a few days we had the part. All of this was done at absolutely no cost to the Association. The board and many of the PPA membership who attended the 2018 annual meeting have come to accept the fact that in order to manage our weeds, we need an up to date approach, and some new equipment. These issues are noted within the content of this publication, and are presently being addressed.

So that we move continue conquer our challenges, and reach our goals, I hope that our board and the PPA membership, will continue with their cooperation, and voluntary efforts, by doing so, I am fully confident that we can accomplish great things. 2018 PPA Annual Membership Meeting

2018 PPA Annual Membership Meeting was well attended. Both the Secretary's Minutes, of the 2017 Annual meeting and the current annual Treasurer's Report were distributed and approved. A handout of the 2019 Budget was provided and explained. Our annual Comprehensive Financial Review has been completed, and everything has been found to be in order. Election of Officers and District representatives resulted in the following: The offices of President, Secretary, and District Representatives stayed the same, except for District 6 in which Andrew Bishop was elected. We welcome Andrew to the board, and also thank Jim Whitehead for all his time given and the work that he provided during his tenure as our District 6 representative.



Financial Status

As reported at the annual meeting as of 7/31/18. Our income for the 2018 fiscal year was \$69, 850.84 and expenses were \$51,145.65. Our total cash assets were \$68,271.69. We estimate that on 12/31/2018 will be somewhere around \$35,000.00.

Weed Control/Lake Maintenance

In May we started chemical treatment of the curly pond leaf. We had great results. Then, as we were prepping our weed-harvester for its launch, some major mechanical issues surfaced. These had to be corrected, if not addressed they could have caused catastrophic damage to harvester and would have created safety issues for our operators. Unfortunately, due to the age (38+ yrs) of the harvester, parts were not available and had to be fabricated. This caused a significant delay to our weed removal program.

Terry Radtke has spent over 80 hours performing maintenance. In contrast, less than 60 hours were expended on the actual operation of the harvester on the lake. Eventually, this past summer it was decided that the repair activity was more than Terry alone could handle. Since hiring the maintenance would cost at least \$80 per hour as opposed to the \$14 per hour the association pays Terry, it was decided that this year, continued repair activity would not be economically viable. As stated earlier, at the annual meeting, a presentation was given summarizing the investigation prompted by the decision to suspend operation of the old harvester. Three options were investigated: using an outside professional service to repair and maintain it, continue to use the harvester until it can no longer be operated; outsource the lake weed harvesting to an outside service, or replace the harvester with a new machine.

Estimates of the first option lead us to conclude that the cost would quickly and exponentially increase until the price of a new harvester would be exceeded within four (4) years. Estimates of the second possibility indicated that costs would be in excess of replacing the harvester within two (2) years. The investigation lead to the conclusion that even though it was estimated that a new harvester will cost in the neighborhood of \$100,000, it seems to be the most cost effective solution for our specific needs. However, in order to determine the best course of action for the PPA, the Board of Directors has asked Terry Radtke to work with the manufacturer of the new harvester and explore any other viable options. A plan is in the works for next year's harvester program. The board has discussed equipment versus chemicals. We prefer to use the least amount of chemical as possible. Weed cutting and removal were discussed. During prior years, we have been mechanically cutting the weeds, then at several locations around the lake, deposited them along the shoreline. They would then dry and naturally decompose. We are looking at the benefits of entirely removing weeds from the lake via a harvester conveyor system (estimated cost \$30K). This process would more than likely require a 2person crew. If we were to centralize the conveyor, it is estimated that the travel time for the harvester to go from one end of lake to the other to unload it would require in excess of seventy (70) hours per season. This is time harvester would not be cutting weeds. Hauling the weeds to a remote disposal site would require an additional ongoing expenditure. We are estimating it will be somewhere in the five thousand dollar range (\$5K). Extensive discussion and research has been expended brainstorming how to set up and effectively operate a weed removal program. We still have many unanswered questions. We will continue our efforts to fine tune this process so that it is both beneficial to the lake, and

financially affordable. If you have any ideas, or related information, please feel free to contact us.

This fall, as in past years, we will be removing the dam stop log so that we can achieve the lakes winter level.

Wetlands

Arleen Corson continues to head up the huge project which has brought wetland area up to state standards. Through her, and several other volunteer's efforts, we have been relieved of our state mandated regulations. This past summer, wetland plants were abundant and quickly grew. Many new colonies of native species have developed. In the long run, the new plants will help to keep out the unwanted invasive species, and will allow us to stay in the good graces of the state and federal agencies that will continue to monitor us.

The PPA has received a letter from Ryan Cassidy of the US Army Corps of Engineers. It releases us from our formal yearly inspections. The letter specifies that we obtain a release under 401 Water Quality Certification. We must also provide and file with the county a copy of the conservation easement for the mitigation site. Larry Clough is working with the government agencies on this issue.

In the meantime, the volunteer group has continued to monitor the mitigation area for any unwanted invasive species. Any Purple Loosestrife that had been found has been removed. The numbers of invasive plants are at an all time low, but outbreaks continue to be noted. They are being dealt with on an as needed basis. Some native species noted growing in the wetland are Iris colonies, Hibiscus, Round Leaved Ragwort and Golden Alexander. In addition Sedges, Forbs and grasses have also been observed.

Arleen Corson, Linda Minnick, Patty Schwartz and Katherine Kratzer all have been volunteering to work in the wetlands to keep it in shape. Anyone wanting to join in the effort is welcome. To coordinate days, dates, and times, please call Arleen at 574 457-6796.

Dam/Levee Inspections

Our dam/levee inspections have gone well. However, the Turtle Crossings have presented quite a challenge. Due to both human traffic and various animals using them for lake access, maintaining the crossings has been both time consuming and costly. These four areas are impossible to police and keep to blueprint specs. Looking back to the engineering firm that designed our dam, it was noted that our number one priority is to protect the integrity of the dam. That is our goal. As we do not want the top edge to erode, there is a good possibility that we will replace the crossings with riprap. The east dam concrete armor flex is nicely filling in with natural greenery. More than likely, within the next few years the armor flex will no longer be visible.

Larry Clough continues to work on our Emergency Action Plan. He is compiling a list of requirements that the plan must meet. As in the past, he has continued to work with the IDNR and the Association of State Dam Safety Officials to develop contacts among experts that can help us with the EAP.


Monetary Donations Needed
