then epoxy fill until decision is made about a more permanent solution, upstream riprap moves causing the cracks, 2023 report wanted the cracks attended within 6 months, we just received the report (September 2024), no major changes, Marshall not an engineer, has worked for civil engineers, has built and operated infrastructure throughout Indiana, would like to keep an eye on things until the first of the year to evaluate the extent of repair needed, before picking an operator or changing any procedures, anyone who would like to go out for a look is welcome, right now interested in finding the Dam operating permit, it's important, they could dictate how we do things, believes in self help where we put together a sensible plan within our budget, if engineering is required for studies and plans it can get very expensive Pat- 43-7 is something (State ID 43-7) the Biennial Inspection by an Engineer is required by the state, if we need an engineer every 2 years I would like to see that in writing, we may want to shop that around, it appears Terry did most of the work required for the report, it appears a lot of the report is just duplicated year after year, we need the permit to know what is required Bernie- if the 2 year inspection is required it may be in the state statute Linda- this report states an EAP is not legally required, it could be an anomaly of the unchanged dates, Pat- state statute didn't come into effect until 2022 Marshall- wonders about the quality of the inspection based on these things Bernie- there is a state department for high hazard Dams we could contact Marshall- we are doing some dailys, will do the 4Q Inspection and report to the Board, we want to keep it all in the open so everybody knows what's going on Patwe got the 2021 report and letter from DNR still don't have the DNR letter for 2023, there have been 3 different people in charge during that time span

- c. Marshall- I don't see anything that needs attention this year, looked at the 42" outlet yesterday 1 seam seeping, typical of concrete pipe seams above the frost line in IN
- d. Shane- winter water level? Marshall- We are down apx 6" now, Pat- last year we had minus 12", Paul- pull the 9" that's on top now leave open through the winter
- E. Mark- tried to get with Terry on his procedures, didn't work out, process for replacing Terry and when? Would like to have decided before the Spring season

Pat- weekly water level, Linda doing, monthly weather report from NWS both part of our maintenance plan, quarterly reports are all in Terry's records they are referenced in the biennial reports, been through Terry's files, in process of digitally recording, there was a Dam Committee, there is a Dam Operator position
 - b. Marshall- need to understand work required & amount of time before assigning to someone
 - c. Dan- how long to determine what is required? Report to the Board so a decision can be made

 - C. PPA Documentation/ File Retrieval
 - a. Mrs. Corson gave Linda a box of files that appear to be Larry Clough's, they have been integrated into the file room
 - b. Shane- any idea how many more? The file room was built to accommodate the file cabinets that exist in Corson's garage, 3 cabinets including a map file
 - c. Steve- will look into a file cabinet from his church
 - D. STR- Shane
 - a. Previously discussed sending to PPA Members the letter Anthony sent to his constituents plus a highlighted copy of the ABC's, solid idea to send ABCs, a letter to say why the Board acted in that fashion doesn't represent everyone that's here now, not in favor, Steve Longstreet, based on his email, has done a lot of research, we need to be more transparent for everyone about the legal rights of the PPA and the members, wants to see the info from the attorney that the previous Board has retained, so he can understand what we need to do, wants to be unbiased, can't represent anyone in the PPA without that knowledge
 - b. Mark- spent time going over the ABCs could offer his interpretation today Sherry- has also spent time with the ABCs, Bernie- also
 - c. Shane- we all have and have differing opinions, we need to come to common ground
 - d. Bernie- the way is by english grammar, it says the Board 'reserves the right' that is not a command to do something, it is a choice, the Leasee who resides there having the same rights as the owner only pertains to fishing rights
 - e. Dan- we agreed we need to move forward, Shane & I, on opposite ends of the spectrum were to try to come together, bring a recommendation to the Board, Anthony wanted to go a step back, that he has an understanding of the ABCs pertaining to STR and all members should have an understanding, could be accomplished with a highlighted version, that the Board could also benefit from this understanding, Anthony wanted to be involved in that conversation, he couldn't attend with the date being changed but ok with the meeting proceeding if the STR issue was off the table, only fair if we don't continue this discussion until he is present Mark- agrees not to make a decision without him but not that he needs to be here for the discussion, not ready to send any interpretation to members if we don't agree, maybe decide what language we need an attorney's opinion Marshall- Words have meanings, how is there an interpretation to the meaning of a word? Mark- we need to identify language that's relevant to the question Sherry- can we

go through the Board to take a pulse of where each Director is on the issue? Steve- it seems we have extreme no STR, extreme STR with no regulation, middle ground STR w/ guidelines, would like to know who is in which group to make discussion more targeted Sherry- of the opinion that the ABCs do not allow STR, if you want to allow STR then the terminology would need to be changed

- f. Marshall- Darby, Dan, Shane, Steve w/Linda should look at the survey so you get a feel for what the members are thinking Shane- has wanted to do a 'legitimate' survey since he got on the Board, wants to know how many responses (157) he didn't send his in Linda- there is personal information included
- g. Bernie- it doesn't matter what the Board thinks, it's what the Members want, this is a simple way to find out if the people want them or not (has a hand out that asks for a yes or no answer)
- h. Dan- there are 2 issues 1) do the ABCs as they stand now allow or not allow STR? 2) if the ABCs do not, then can we provide for an amendment that makes it blatantly clear? It is all the PPA's decision but the Board is obligated to govern within the ABCs, Anthony has provided a gateway to get to those answers by educating the Board & educating the membership, Step 1 we have agreed to send the ABCs to the Members, Step 2 the Board talks about ABCs, do you or do you not? Why or why not? This is why Anthony wants the Board to have this discussion
- i. Shane- who will inform us exactly how to read the ABCs? Bernie- english grammar, there is nothing that says you can't rent a property for so many days

 - 3. Dave Selman- in reference to the seawall decisions- you need to be aware of the process of construction being used, different impacts to the Lake bed
 - 4. Jon Korejwa- if you think PPA has been unfairly required to adhere to 'extra' regulations you could get our State Rep involved, the survey was a type of vote, if the Members don't know or don't have the ABCs that's their responsibility
